Review of last year's activities:

Good news: Snow plowing: light year. Saved almost \$4000. Two light years in a row.

Bad news: 4 major storms in a week, roads severely damaged. Spots have been identified. If you notice something that hasn't been identified, please let the board know.

Weed control: sprayed for weeds this year, got a better deal than previously. May be able to spray every year. Goal not to kill grasses, weeds only. County approved formula used on our roads.

Budget of \$6k for road maintenance. Could spend \$12 to 14k to repair roads from the storms. Detailed summary will be sent out once the repairs are finished. Have already put in 6 loads of gravel, at least another 6-10 loads coming. Work will continue throughout the summer. Biggest problem will be roads that need re-rocked...shortage of rock and subsequent increase in price due to demand.

Mike walked through the budget. 93% of scheduled monies came in. Refer to budget previously sent for details.

Medstar presentation.

Total burn ban. NO fireworks. Can have propane bbq.

Quorum present to talk about new business. Any new business?

Question that maybe the HoA could instigate a burn ban earlier than other legislative bodies. Association has no choice but to follow DNR rules, so can't lighten them Checking to see if TLC can legally be forced to pay past dues.

Meeting Q&A session:

Opinions on where rock should/shouldn't be placed.

Clarification: Grass on road should be killed, but not grass off of the road.

Complaint that there was spraying without notice.

Question that HoA speed limit rules were changed to 20 from 15 by the state.

Question about speed bumps. Not sure how it could be done.
